This project is aimed at proving to the world that CRYPTOCURRENCY IS REAL.

Also, this project will prove beyond all reasonable doubt that PEOPLE CAN STILL MAKE HUGE PROFITS FROM ICOs AND CRYPTOCURRENCY.

This project will reassure all those who have lost confidence in online investment as well as cryptocurrency investment and trading, proving to them that their losses can still be recovered with a good project like this.

A lot of people have lost money in the past because of wrong investments. While these investments looked so promising at first, they later turned out to be shallow projects with no reasonable product to back up the token's value.

WHAT PROBLEM ARE WE SOLVING?

The big problem right now is that very many projects have no value because there is no use case to back them up. Many project developers only code/build their coins/tokens, not the actual project. When ICO is done, investors keep waiting and waiting and they also keep getting empty promises with no real work to add value to the project.

Also, most crypto developers have made cryptocurrency look like a pseudoonline-joke, run by various puppeteers. WHAT MAKES US DIFFERENT?

(1) Online and Offline Shopping:

[Easy conversion of other currencies to EVTs]

Over the years, there has been a challenge of shopping online with various currencies in the world. Many online stores have limited variety of accepted currencies and they shut out all those without such currencies. While we also maintain and adhere to accepting only our Elevation Tokens (EVTs) for the purchase of goods and payment for services on our platforms, we shall integrate a mini exchange into our platform to accommodate several other currencies (both crypto and fiat) that buyers may come with.

Our mini exchange will convert your digital (or fiat) currencies to our Elevation Tokens (EVTs) with ease and you can shop immediately on our platform. With this idea, we will

accommodate all kinds of people from various parts of the world and shopping will be limitless.

(2) Turning Delivery Centers to Local Stores: [Not just online, but visible in your locality]

Most online stores usually don't have a physical base or location where goods are stocked, they only have delivery centers to pick up goods after buyers have paid online. This is because their goods are limited or there is no visible warehouse. While we plan to start with the online store and some delivery centers, we shall gradually turn those delivery centers to real local stores (filled with goods). People can easily walk into our local stores and make purchases directly and pick up their goods immediately with their EVTs. With this idea, we would serve both online shoppers and other people in various locations where our local stores exist.

3. Training Non-Crypto Enthusiasts:

[Reaching out to those who have never heard of Bitcoin or EVT]

Our online and local stores as well as our Crypto Academy will be structured to process payments only with our Elevation Tokens (EVTs) cryptocurrency. What about those who are non crypto-literate? What happens to the common man on the street who knows nothing about Bitcoin or Ethereum or Elevation Token, yet he desires to shop with us? Should we shut him out because he knows nothing about crypto? No! An agent at the online or local store can quickly coach the person on how to get some EVTs and make payments instantly. After the brief coaching and shopping, the agent then recommends that he should improve on his crypto knowledge in our crypto academy. Such a person can enroll in our crypto academy and be trained successfully on how cryptocurrency works and how to use it. This is why our crypto academy is very important.

(4) Business Advertisement:

THE USE CASE OF ELEVATION TOKENS

What will Elevation Tokens be used for?

In Cryptocurrency, the use-case of a coin is paramount to its exposure and acceptance. When a coin has a valuable use-case, it will be very easy to attain mass adoption and general acceptability.

We are delighted to inform you that our Elevation Token has a lot of use-cases. Also, our official commercial price, as it will be accepted on our platforms will rate 1 EVT = \$0.5.

All those who will participate in our Pre-Sale and ICO will reap massive profits because of the use case and the value we shall officially attach to Elevation Tokens (EVTs).

Below are various Use-Cases for EVT:


1. Payment for Online/Offline Shopping: When our project launches fully, Elevation Tokens (EVTs) will become very valuable. The EVTs will be used to shop in our online and local stores worldwide; buyers will be required to place orders using the EVTs, while sellers will accept EVTs as payment for goods and/or services rendered.



2. Payment For Crypto Training: The Elevation Token (EVT) will be the only payment processor for our cryptocurrency training. All new students will be required to pay tutorial fees with EVTs. We will also integrate the EVT payment portal on the Cryptocurrency Academy portal.



- **3. Payment for Advert Slots:** Businesses and organizations will be required to purchase some EVTs for placing adverts on our platform. We shall structure out various advert slots with certain required number of EVTs.
- **4. Exchange Fee for Converting currencies:** Usually, exchanges take some transaction fees for converting from one currency to another. Our Mini Exchange will also charge certain transaction fees when people use the service. Our exchange transaction fees shall be charged in EVT and this applies to every exchange process that is done, either per transaction or for multiple transactions.

EXCHANGE LISTING AND TRADING

We are already in talks with some exchanges to list EVT; we will update info when confirmed. Please be informed that exchange listing and trading of EVT will officially commence after Coin Distribution in February-March 2019 as stated in our Road Map.

THE OFFICIAL VALUE OF ELEVATION TOKEN (EVT)

When we launch our services fully, the value of Elevation Tokens (EVT) shall be rated at \$0.5/token. All goods in our online / local stores will be sold using \$0.5/token of EVT. For example, a mobile phone worth \$100 will be sold at 200EVT (that's \$1 = 2EVTs). This same value applies to other services such as our Crypto Academy fees and all Advertising Slots that shall be offered to businesses and organizations.

We shall maintain the price and continually improve on it with all our services; it will be very difficult for the price of EVT to crash down. This will give back massive profits to all investors who joined the Presale and ICO stages of the project.

PROFIT CALCULATOR

For Example, if you invest \$200 into our Presale at \$0.005 per token, you will get 40,000 EVTs, after our full launch, the official value will rise from \$0.005 to \$0.5, that \$200 investment will return a 100x value, that's \$20,000. This is real, no jokes, no hypes!

As stated earlier, all our stores and services will rate EVTs at the value of \$0.5/per token. When we set the prices of our products at the online/local stores at \$0.5 per token, it will be difficult for people to go and dump the tokens at the exchange. It will be unreasonable for someone to sell his/her tokens for \$0.1 or \$0.3 when they can easily buy goods from our stores at \$0.5 per EVT.

With the strategy described above, more people will be attracted to buying goods, instead of dumping at the exchange. When the tokens are under control, we can gradually maintain the value of EVT and determine the price at the exchange too. By this, even traders on various exchanges will gradually adjust to setting their sell orders at \$0.5 per EVT. This is practically possible because Elevation Token is not a shitcoin; we have real world applications and valuable use-cases for our token.

THE ELEVATION PLATFORM (TEP) PUSHING FOR WORLDWIDE ADOPTION

We have a reliable strategy that will propagate the awareness of The Elevation Platform and the Elevation Tokens (EVTs) to spread worldwide and reach the masses.

We will gradually push for worldwide mass adoption through the following means:

- *Seminars and Presentations
- *Continuous opening of local stores and Crypto Academies in various parts of the world
- *Trainings and Empowerment Schemes
- *Special offers and bonuses
- *Several Partnerships across the world
- *Recruiting of various TEP (The Elevation Platform) coordinators worldwide

A Regional TEP coordinator will oversee all the states in a Zone (North-East region, South-South region, South-East zone or West)
- (3) **State TEP Coordinators:** A State TEP Coordinator should be a Pre-Sale investor or the First investor from that state, though there are other terms and conditions to qualify, but such a person should be capable of creating awareness about The Elevation Platform in that State and he/she should be able to recruit more investors from that state. A state coordinator will oversee all the cities in that state.

- (4) City TEP Coordinators: A City TEP Coordinator should be a Pre-Sale investor or the First investor from that City; though there are other terms and conditions to qualify, but such a person should be capable of creating awareness about The Elevation Platform in that City and he/she should recruit more investors from that City. A City TEP coordinator will oversee all the towns in that city.
- (5) Town TEP Coordinators: A Town TEP Coordinator should be a Pre-Sale investor or the First investor from that Town; though there are other terms and conditions to qualify, but such a person should be capable of creating awareness about The Elevation Platform in that Town and he/she should recruit more investors from that Town. - *They will be recognized as official representatives of TEP in their locations
- *They will be entitled to Free Trainings and Seminars

All three (3) people listed above MUST enroll and be trained at our crypto academy to qualify for their jobs.
